## Health, Safety & Environmental Statement

Our company strives to ensure that the health, safety and environmental standards are achieved and maintained to the highest levels.

 Our company aims to ensure that its employees are exposed, as far as is reasonably practical, to minimum risk; and that the environments operated in are affected minimally, whilst maintaining acceptable standards.

#### C3 Food Services will strive to maintain the highest standards possible including:

- Develop and maintain a Health, Safety and Environmental Management
   System (HSMS) throughout the organisation which will ensure that a high level of legal compliance is achieved and that, where necessary, best practices are followed to enhance this management system.
- Carry out a regular audit of the HSMS against an established audit protocol ensuring, where implemented, a compliance level of at least 85% is achieved.
- Implement a risk identification programme which will ensure that when a project is started, all the risks are identified and that risk assessments are carried out on a regular basis following commencement of the project. All work carried out must be assessed and monitored on a monthly basis.
- Implement precautionary measures as identified in terms of the risk assessments carried out.
- Ensure that precautionary measures are effective and have been developed to
  ensure that the identified risks are either removed, reduced, or if impossible to
  remove, that they are managed accordingly.
  - Ensure that incidents are reduced and that employees, residents and the environment are minimally effected.
  - A lost time incident rate of zero must be achieved. Environmental incidents must be reduced so as not to exceed one per month per operation.
  - Undertake all activities in such a manner that they will not undermine or cause conflict with other health, safety and environmental principles and objectives.

- Ensure that finances are allocated to manage health, safety and environmental requirements in the most cost effective manner possible.
- The policy must be reviewed by management and the health and safety committee annually.
- Policies and procedures to enhance this policy and the HSMS must be developed and implemented throughout the organisation.
- Continuous improvement in respect to health, safety and the environment must be maintained at all times.
- The contents and intent of this policy must be communicated to all employees and interested parties on a regular basis.

### Code of Conduct
